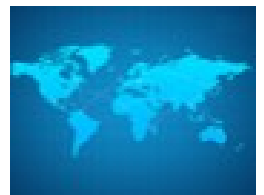


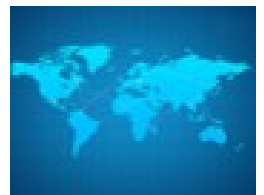

Voting procedure



Procedure to approve CIML resolutions

- Uses “CIML Meeting Resolutions Voting” tool on “My access” menu of the OIML website
- Voting open for 30 minutes at the end of each meeting session
- Voting only possible by Heads of Delegation –
Assignees cannot vote

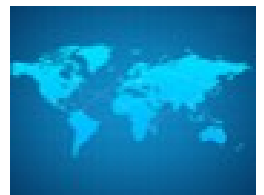


Quorum for the approval of CIML resolutions

- Application of the requirements of OIML B 1:1968
OIML Convention, Article XVII

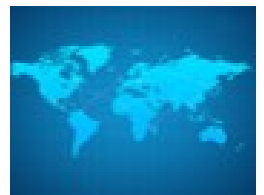
“Decisions shall be valid only if the number of those present and represented be at least three-quarters of the number of persons designated as Members of the Committee and should they be supported by a minimum of four-fifths of the votes cast. The number of votes cast shall be at least four-fifths of the number of those present and represented at the session.

Abstentions, blank and null votes shall not be considered as votes cast.”



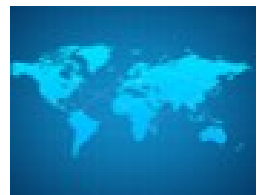
Quorum for the approval of CIML resolutions

- Number of CIML Members = 62,
- Three-quarters of this number = $62 \times 3 / 4 = 46.5$
- 47 CIML Members are therefore required to be present or represented. **This will be taken as the total number of “Yes”, “No” and “Abstain” votes in the online voting**
- 80 % of CIML Members present or represented then need to cast a vote
- Resolutions then need to be supported by 80 % of the votes cast
- **In the last two bullets, abstentions and failures to vote shall not be considered as votes cast**



Procedure to approve CIML resolutions

- Each resolution can be voted on separately, or you can vote “Yes to all”
- Text of resolution will be presented
- Option to vote “Yes”, “No” or “Abstain”
- No comments necessary



Procedure to approve CIML resolutions
